Open Forum – ten minutes to receive questions and comments from members of the public

Councillors discussed dog waste and general litter. It was noted that this seems to be a universal problem.

The problem with pot holes were also raised. Cllr. Francis stated that the PC do as much as possible to address these issues by ensuring that they are reported to the relevant County Council department and that any outstanding issues are followed up.

The planning application 22/00925/FUL. was discussed. Councillors agreed that the new plans are preferable to the old however it was also acknowledged that the entrance to the property may be problematic.

Councillors noted that the two quotes to replace the Village sign have now been received and that the quote from Morris signs is more comprehensive and therefore preferable.
