

## WESTON PARISH COUNCIL

### Minutes of the electronic Meeting of the Parish Council held on Wednesday 3rd March 2021 at 7.30pm

**Present: Councillors D. Chase, G. Francis, C. Laughton, P. Laughton, R. Henderson and H. Saddington.**

210301 To receive Apologies for Absence and Declarations of Interest  
**All Councillors present. Also in attendance Cllr Bruce Laughton and Cllr Sylvia Michael**

Open Forum – ten minutes to receive questions and comments from members of the public  
**No members of the public were present.**

210302 To accept the minutes of the meeting held on 3<sup>rd</sup> February 2021  
**Accepted. Proposer – Councillor P. Laughton, Seconder – Councillor G Francis.**

210303 To note and report matters arising from the minutes not covered elsewhere on the agenda

- i) Parish Clock update  
**The Clerk read 2 emails received from the Weston PCC advising that the application was now with the Registrar and should (hopefully) be authorised by the Chancellor very soon.**
- ii) Update on Rural Broadband Scheme  
**Councillor G Francis reported that based on 146 properties, the quote from Open Reach was £174,326, which equates to £1,194 per property. The current voucher scheme would offset much of this cost. This ends at the end of March, but is likely to be replaced by a similar scheme on similar terms. The response of the village has been positive. Open Reach have been asked to put together a firm proposal. It was noted that if local business signed up for the scheme, the cost would be lower.**

210304 To receive reports from County Council and District Council Representatives  
**Cllr. Michaels reported that Safer Neighbourhood meetings were not taking place at present as there is no PCSO at the moment.**  
**She reported that there were 2 parties interested in the Cattle Market, and that there were advanced negotiations taking place with one of them. There will be a report to the Development Committee on 24<sup>th</sup> March.**  
**COVID vaccinations continue at a pace, with cohorts 1-7 now able to have vaccines.**  
**NSDC has received £25million funding in the Budget for Town Funding.**  
**6031 Grants amounting to £34.99million have been made during the COVID-19 crisis and £145,000 remains in the budget, from which 400 businesses may benefit.**  
**Cllr Bruce Laughton reported that there was a 3% Council Tax increase from Notts CC.**  
**He advised that he will not be attending future meetings due to the May elections**

210305 To receive and consider any highways issues:  
**Cllr H Saddington reported that the footpath opposite Hutchinsons on the Great North Road was difficult for wheelchair access. The Clerk will put in a report and request for action.**
